- Until the Rosewood Dr extension to Chaparral Rd is completed, all enrolled students and their siblings living in the Tuscan Meadows subdivision will be allowed to apply for a transfer back to Skipcha. As is true for all transfers, parents/guardians will be responsible for transportation to/from school each day and students must remain in good standing in the areas of discipline, attendance and punctuality.
