#### SUMMARY

Performs onsite preventive maintenance, troubleshooting, replacement, installation, and repairs to KISD's video surveillance system. Keeps logs and reports as directed regarding work performed and actions taken. Must be able to communicate technical details in a clear understandable manner. Must be flexible, as most work must be performed in a manner with the least disruption to campus operations as possible.

#### ESSENTIAL DUTIES AND RESPONSIBILITIES include the following:

Performs onsite preventive maintenance to camera system, to include dome cleaning and rotation.

Ability and willingness to comply with safety regulations.

Must be comfortable and able to safely work at heights, which often will exceed eight feet.

Ability to safely perform work on a ladder and to safely operate lifts of various types.

Knowledge and ability to conduct onsite troubleshooting of various digital IP camera systems.

Skill and ability to safely and competently install/mount digital IP cameras to various surfaces including (but not limited to) drop ceiling panels, sheetrock, brick/masonry exteriors, etc.

Ability to trace and conduct ethernet line tests.

Understanding and knowledge regarding the basics of PoE, IP/TCP networking (to the extent needed to get a device on a network), and a general understanding of IDF/MDF closets.

Skill and ability to cut and crimp ethernet cables.

Skill and ability to configure digital IP cameras with supplied network details so the device can connect to the network.

Ability to communicate technical details in a clear and concise manner.

Ability to conduct services and work with a customer first attitude.

Must be able to comply with safety regulations regarding dust and particulate matter. Must be comfortable performing work at heights while wearing the relevant safety devices as each specific job requires (eye protection, gloves, N95 mask, safety harness, hard hat, etc.). Must have effective fine motor skills while in awkward or uncomfortable positions.

#### WORK ENVIRONMENT

While performing the duties of this job, the work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Occasional district-wide travel to multiple campuses as assigned. Work will be performed both indoors and outdoors. This job will involve exposure to varying temperatures, noise levels, and weather conditions. Due to exposure of cleaning chemicals, dust, mold, and animal droppings, work will often be conducted while wearing various safety devices (gloves, masks, hard hat, etc.). Frequent exposure to heights exceeding 8 feet.
