#### **SUMMARY**

To increase student achievement through the use of technology

### ESSENTIAL DUTIES AND RESPONSIBILITIES include the following:

Develops, and models for students, classroom projects that integrate technology into the four core curriculum subjects: ELAR, Math, Science and Social Studies.

Assists teachers with integrating technology into the core curriculum areas to improve student achievement.

Assists campus administrators and teachers in identifying opportunities to improve instruction and student performance through technology-based solutions.

Maintains knowledge of all core curriculum area TEKS.

Researches and recommends technology solutions which increase student achievement to campus instructional leadership.

Assists in evaluating the implementation of technology on the campus.

Stays current on innovations in technology and curricular issues involving technology which impact student achievement.

Conducts professional development regarding technology and its impact on student achievement.

Previews and makes recommendations for ordering hardware and software for student use.

Performs other duties as assigned which impact student achievement.
