AGENDA ITEM #1, WELCOME AND INTRODUCTIONS

Mr. Kelley welcomed the committee and thanked them for their participation.

AGENDA ITEM #2, REGION 12 INTRUDER TESTING RESULTS (551.076, 551.089)

Texas Education Code 37.109 grants authority to the School Safety and Security Committee to convene in closed session as provided by Texas Government Code, Chapter 551. The committee convened in closed session at 4:07 p.m. in accordance with the Texas Open Meetings Act to discuss agenda item #2, Region 12 Intruder Testing Results, as allowed by Texas Government Codes 551.076 and 551.089. No action or voting was taken in closed session.

The District School Safety and Security Committee received the Texas School Safety Center's Intruder Detection Audit for specific campuses on May 3, 2023. As a result of discussion in closed session, Dr. Buckley moved to approve the campus safety corrective action plans for specific campuses to address audit findings. Mr. Rich seconded the motion, which carried unanimously.

AGENDA ITEM #4, UPCOMING EXPECTATIONS OF INTRUDER DETECTION AUDIT RESULTS

Mr. Kelley discussed the remaining schools that should be at the top of the list for the Intruder Detection Audits for the next school year.

AGENDA ITEM #5, SCHOOL SAFETY AND SECURITY DISTRICT AUDIT REPORT UPDATE

Mr. Kelley discussed the Safety and Security District Audit Report. *Texas Education Code* 37.108(4)(b) requires districts to complete Safety and Security Audits of their facilities at least once every three years in accordance with procedures developed by the Texas School Safety Center (TxSSC). The Audit includes polling of students and staff, and these results are sent to the state. The Audits are quite extensive; however, KISD has streamlined the process. All KISD students need to be trained in school safety vigilance.

Mr. Kelley notified the committee that Region 12 is slated for on-site Threat Assessment Training for new Threat Assessment Team members. Maria Thomas, Fort Cavazos CID Special Agent, informed the committee of the upcoming Fort Cavazos Freedom Festival at Phantom Warrior Stadium on June 23, 2023.
