Distinguished Alumni Criteria 2026



Qualifications of Nominees:

- Nominee must be a graduate of Killeen Independent School District.
- Nominee must have graduated 10 years prior to the year he/she is nominated.
- Nominee cannot be a current employee of Killeen ISD.
- Nominee should be well-rounded in all areas and significantly contributed to the community (Killeen or another community) and/or his or her profession since graduating from Killeen ISD.
- The honoree should be a role model that current and future generations of Killeen ISD students can emulate.
- Killeen ISD Alumni Association committee members, Killeen ISD Education Foundation board members, KISD Board of Trustees and individuals currently seeking election/re-election to public office are not eligible to receive the award.
- KISD Alumni Association committee members may not make nominations.
- If the candidate is not chosen this year, nominations will be kept on file for consideration for two additional years following the submission date.

To nominate a candidate:

- Nomination forms may be obtained from the KISD Education Foundation office by calling 254-336-0181 or online at www.KilleenEducationFoundation.org.
- All questions must be completed. Please provide enough information about the candidate to clearly demonstrate the contributions they have made.
- **Resumes will not be accepted in lieu of the nomination form but are recommended to be submitted along with form.**
- Nominations must be submitted to the Foundation office no later than **December 31, 2025.**

Method of selection:

- The KISD Alumni Association Distinguished Alumni Committee will review all nominations and select potential honorees.
- All honorees will be asked to submit a complete biographical sketch and photo no later than January 31, 2026 to be considered.
- Honorees will be selected and recognized at the 2026 Distinguished Alumni Reception – date and location to be announced

Additional Information:

- The KISD Alumni Association is unable to provide transportation or lodging expenses for awardees to attend the recognition ceremony.
- Nominations are reviewed and valid for a period of three years.
